**1. SWEEPSTAKES DESCRIPTION:** The Jiffy Lube Ontario *"Pennzoil® VIP Indy Race Experience"* (the **"Sweepstakes"**) is sponsored by QLO Management Inc. and JL Management Group Inc. (collectively the **"Sponsors"**). The Sweepstakes begins at 12:00:00 a.m. (midnight) Eastern Time (**"ET"**) on May 16, 2016 and ends at 11:59:59 p.m. ET on June 12, 2016 (the **"Sweepstakes Period"**). If you enter during the Sweepstakes Period, you will be entered into the Grand Prize Drawing (defined below). Individuals who participate in this Sweepstakes (each an **"Entrant"**) agree to the Official Rules and the decisions of the Sponsors which shall be final in all matters relating to the Sweepstakes. All time references in these Official Rules are Eastern Time.

**2. ELIGIBILITY:** The Sweepstakes is open to legal residents of the Province of Ontario, Canada, who are eighteen (18) years of age or older at the time of entry and who hold a valid driver's license. Entrants must be an AIR MILES<sup>®†</sup> Collector, (**"AIR MILES Collector"**) (AIR MILES Reward Miles are collectively referred to in these Official Rules as **"Rewards"**) at the time of entry. In Canada, the AIR MILES Reward Program is owned and operated by LoyaltyOne, Co., and enrollment is free and available at [www.airmiles.ca](http://www.airmiles.ca) via a computer or a web-enabled digital device (smartphone or tablet); by enrolling to become an AIR MILES Collector, you agree to be bound by the terms and conditions of the AIR MILES Reward Program as amended from time to time. Sponsors’ assignment of time stamps to any entry will be final. In the event a dispute regarding the identity of the individual who actually participated in the Sweepstakes cannot be resolved to Sponsors’ satisfaction, the affected individual’s entry, will be deemed ineligible. Those who do not follow all of the instructions, provide the required information in their entry or abide by these Official Rules will be disqualified. Entries submitted on your behalf by any other individual, by you on behalf of another, or by any entity, and entries originating at any online service other than the website ([www.jiffylubeontario.com/indy-race/](http://www.jiffylubeontario.com/indy-race/)), including, without limitation, any commercial promotion subscription, notification and/or entering service, will be declared invalid and disqualified for this Sweepstakes. As a condition of entering the Sweepstakes, each Entrant gives consent for Sponsors or their representatives to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and complying with applicable laws, regulations and rules.

**4. PRIZES/ODDS Of Winning:** There are two prizes available to be won. The first prize (the **“2016 Honda Indy Toronto Race Experience Prize” or “Grand Prize”**) is a Grand Prize for six guests on July 17, 2016. The Grand Prize consists of: tours of Penske Hauler and Team Paddock; communication with guests pre-race to assist with travel and parking; a driver meet-and-greet; \$1,000 CAD dollars; one photo with a Penske IndyCar driver for six guests. The second prize (the **“AIR MILES Reward Miles Prize” or “Second Prize”**) available to be won, consisting solely of Bonus Card worth 5,000 MILES Reward Miles awarded to the winner’s Collector account. To deposit your reward miles into your AIR MILES Collector Account, visit [airmiles.ca/deposit](http://airmiles.ca/deposit). The two prizes noted above are subject to availability and and may be substituted for prizes of equal or greater value at Sponsors’ sole discretion. Any applicable taxes (including federal, provincial and local sales and income taxes) and all other costs and expenses associated with acceptance and use of the prize and not specified herein as being awarded as part of the prize (including, without limitation, registration, title, license fees, destination charges and insurance) are solely the applicable winner’s responsibility. Odds of winning will depend on the total number of eligible entries received before Sweepstakes closes and number of entrants who follow Jiffy Lube Ontario on Twitter. Entrants that follow Jiffy Lube on Twitter will have a greater chance of winning.

The approximate retail value (**“ARV”**) of the Honda Indy Race Experience (the **“2016 Honda Indy Toronto Race Experience Prize”**) is \$3,050.

The approximate retail value (“**ARV**”) of AIR MILES reward miles depends on the chosen method of redemption, available reward options at the time of redemption, and the set preference between AIR MILES Cash and AIR MILES Dream balances. **5. WINNER SELECTION:** A draw will be conducted at approximately 11:00:00 a.m. ET at 562 Wellington Street London, Ontario, Canada on June 17, 2016 from all eligible entries received throughout the Sweepstakes Period. Sponsors or their designated representatives will select one (1) potential winner (subject to verification) (“Grand Prize Winner”), one (1) additional prize winner (“Second Prize Winner”) and three (3) alternate potential winners. The order the three (3)

potential winners are selected will further be recorded with each earlier potential winner taking precedence over the other(s) in the case an alternative winner(s) is required (see section 6). The Grand Prize Winner may choose between receiving the **“2016 Honda Indy Toronto Race Experience Prize”** or the **“AIR MILES Reward Miles Prize”**. **6. The Sponsors or their designated representatives will attempt to notify any potential winners within three (3) business days of the applicable drawing. The confirmed winner will be able to enter the given deposit code and security code at [airmiles.ca/deposit](http://airmiles.ca/deposit) in order to deposit the Reward Miles directly into the AIR MILES Collector Account. To ensure that the confirmed winner receives the Second Prize in his or her preferred balance, winner should ensure his or her balance preferences (AIR MILES Cash balance and

AIR MILES Dream balance) are set as desired prior to the Prize being posted in his/her Collector Account.

**8. GENERAL:** No responsibility is assumed by QLO Management Inc., JL Management Group Inc., Shell Canada Products, or LoyaltyOne, Co.
